Should the activity be deemed suitable, I/we will be notified (regardless of my/our approval below), and acknowledge that I/we may be asked to sign an additional waiver form specific to that the event or activity. I/we may choose at that time to decline or approve my/our permission.

MEDICAL AGREEMENT AND RELEASE

1. In the case of medical emergency, should I/we not be immediately available for consultation, I/we, as the applicant's parent(s) or legal guardian(s), give permission to the physician selected by CISS MLI, the Host Family or the school officials to hospitalize, secure proper treatment for, and to order injections, immunizations/vaccinations, anesthetics or surgery for my/our child.

2. For simple headaches, fever or other minor pain, I/we permit the host family, CISS MLI or the school staff to administer the prescribed dose of:

Acetaminophen (ex. Tylenol)

Ibuprofen (ex. Advil, Motrin)

3. I/we hereby agree that the relationship and the resolution of any and all disputes arising therefrom between ourselves and health services provided through CISS MLI, the Host Family or the school officials, shall be governed by and construed in accordance with the laws of the province in which the programme is operated. I/we hereby acknowledge that the treatment will be performed in the province in which the programme is operated and that the courts of that province shall have jurisdiction to entertain any complaint, demand, claim or cause of action whether based on alleged breach of contract or alleged negligence arising out of the treatment. I/we hereby agree that if I/we commence any such legal proceedings they will be only in the province in which the programme is operated, and hereby irrevocably submit to the exclusive jurisdiction of the provincial courts.

4. I/we confirm that my/our child does not have any condition (e.g. medical, emotional, mental health etc.) that would prevent him/her from participating fully in and completing the international student programme. I/we understand that should my/our child be unable to complete the programme due to complications arising from emotional or mental health distress, no refund of programme fees will be provided.

The following Participation Agreement has been established by CISS MLI and its partners as minimum standards of participant conduct (Rules and Regulations).

ACADEMICS & GENERAL BEHAVIOUR please initial once read:

1. Behave with respect towards CISS MLI staff, all teachers and school staff, homestay members and homestay programme staff
2. Attend school on a regular full-time basis and attend all classes as per my class timetable and per the designate model of my school for the duration of my programme. Any legitimate day absences (ie. illness) must be explained by a note from my host parent to my school
3. Meet homework, test and exam expectations and maintain an acceptable academic standing (minimum 60%)
4. Notify CISS MLI at time of application of any mandatory courses required by my school or my state for covalidation at completion of my studies in Canada.
5. Remain in my selected courses and not withdraw from or change courses without consent of school officials and CISS MLI
6. Abide by the laws of Canada
7. Obey the rules and regulations of CISS MLI, my school and my host family
8. Use English (or French if that is the target language) when speaking with my teachers, family and friends to make the most of my immersion experience
9. Refuse/deny paid employment while in this programme
10. Refrain from driving ANY motorized vehicle or from being a passenger in a vehicle if the driver is under the age of 25 (*including: car, moped, scooter, dirt-bike, snowmobile, ATV, Sea-doo etc*)

ILLEGAL ACTIVITY please initial once read:

The following are behaviours and laws that must be followed. Failure to obey may result in dismissal from the programme with no refund, and termination of the study permit.

I understand and agree to abide by ALL LAWS OF CANADA (even if unlisted here), with the following being most prolific for students:

11. The consumption or possession of alcoholic beverages is illegal for persons under the age of 19 (18 in some provinces) and is therefore prohibited. Asking an adult (person over the legal age) to purchase alcohol on my behalf is illegal.
12. Entry into a nightclub/disco/bar or other establishment that requires patrons to be over the legal drinking age is not permitted. Use of false identification is fraud, and is punishable by Canadian law.
13. Smoking/vaping is not permitted on school property or inside any public building. Purchase of cigarettes or e-liquid/ e-juice is illegal for persons under the age of 19 (18 in some provinces) and is therefore prohibited to CISS MLI students. Asking an adult (person over the legal age) to purchase cigarettes or e-liquid/e-juice on my behalf is illegal.
14. The use or possession of any type of illegal drugs and/or the abuse of prescription or nonprescription medications is an extremely dangerous and illegal activity in Canada and is strictly forbidden
15. Purchase, use or possession of cannabis in any form is illegal for persons under the age of 19 (18 in some provinces) and is therefore prohibited to CISS MLI students. Asking an adult (person over the legal age) to purchase cannabis, in any form, on my behalf is illegal.
16. Violence, aggression, harassment or bullying has a zero tolerance level and is strictly forbidden behaviour. *Harassment can be a single incident or a series of incidents including words, acts or gestures of a malicious or abusive nature directed at a person or a group of persons for reasons of: academic ability, age, sex, sexual orientation, disability, economic status, language, race, ethnicity, religion, appearance or colour.*

When posting pictures, messages or comments on any social media site (including but not limited to Facebook, Twitter, Instagram, Snapchat, etc), I will respect personal honour and NOT post negative or hurtful messages/photos of my peers, my or anyone's host family, school staff, and CISS MLI staff

- 23. I will behave as a considerate and respectful member of the homestay family/residence family by accepting the selected homestay family, regardless of their race; national or ethnic origin; colour; religion; gender; age; mental disability; physical disability; and/or sexual orientation, all in accordance with the Canadian Charter of Rights and Freedoms.
- 24. I understand that misrepresenting myself on the Application Form may result in an inappropriate homestay placement. If I must be moved to a new homestay due to this misrepresentation (example: not advising of pet or other allergies), I understand that I/my natural parents will be responsible for a \$500 CAD administrative fee.
- 25. I will pay for any and all expenses incurred by me (including but not limited to any losses or damages that I may cause - willfully or accidentally - in the home, residence or school; long distance telephone charges, cell phone fees, internet usage expenses and/or medical expenses.
- 26. I am permitted to visit relatives and close family friends, or invite friends to my homestay, only if I have permission from both my host parent(s) and my CISS MLI coordinator.
- 27. In case of illness, I will immediately inform my host family / residential house parent or contact the CISS MLI Programme Coordinator. Any medical expenses required will be fully covered by my medical insurance and/or by my parents when the medical expenses are in excess of the insured amount or the procedure is not covered by my medical insurance.
- 28. I cannot decide to make any changes to my host family or my school of my own accord. Any change in homestay or school must be discussed, approved and arranged by the CISS MLI Programme Coordinator, per CISS MLI policy.

CUSTODIANSHIP & MONITORING / TRAVEL

- 29. I understand that CISS MLI is my custodian and responsible for me for the duration of my academic programme. I also understand that this responsibility ends when I return to my home country, a new custodianship document is issued, or a release letter is presented.
- 30. If I wish to travel out of town, I must submit a TRAVEL REQUEST FORM at least 2 weeks prior to my scheduled trip, and obtain permission from my CISS MLI Programme Coordinator, who will in turn seek permission from my parents.
- 31. I understand that I am not permitted to travel overnight and/or out of my town without an adult over the age of 25, that all travel must be approved by CISS MLI, and that I am financially responsible for any fees incurred.

DISMISSAL / REFUNDS

- 32. In the event that I do not comply with the above rules and regulations, CISS MLI has the right to terminate my participation in the CISS MLI Jr/Sr High School Programme. If this occurs I may be sent home immediately at my parents' expense.
- 33. I understand that should I be expelled from school and/or the CISS MLI programme there will be no refund of any fees.
- 34. I understand that should I choose to withdraw from the programme of my own volition, for personal reasons, there will be no refund of any fees. CISS MLI may consider force majeure or medical emergencies as exceptions, and will review such situations on a case-by-case basis for partial refunds. However, I also understand that:
 - Should a force majeure cause my school to move to online learning and I am presented with the option to continue my studies online, and I choose to voluntarily discontinue my learning either in Canada (as per local students) or in my home country, there will be no refund of tuition fees as it will be my choice to suspend the educational opportunities provided by the school.
 - Should a force majeure cause my school to close or move to online learning and I am not presented with the opportunities to continue my studies, refund of any tuition fees will be at the discretion of the school/school board and I understand that CISS MLI may not be able to provide a refund that includes tuition fees.
- 35. I understand that dismissal from or voluntary withdrawal from the Programme shall result in termination of custodianship and immediate release of CISS MLI's responsibility as legal custodian. Failure to provide an independent custodian will result in a report to Citizenship and Immigration Canada to subsequently nullify the Study Permit.
